Our Company, Solara Active Pharma Sciences Limited, went through a difficult period during Covid resulting in losses. Post Covid, with the re-introduction of the earlier Management Team, the Company has been able to turn around its fortunes and the year ending March 2023 showed a reasonable EBITDA though overall there was a loss but much less than FY2022. The Company has turned around and for FY2024, it is expected to show a much improved EBITDA and a positive PAT.

The recent Board Meeting also approved a rights issue as well as in the interim some funding by the Promoters. This should ensure adequacy of working capital and investment in fixed assets to meet long-term goals as well as reduce the debts payable to the banks.

The Indian economy is in a strong phase and the capital goods industry to which I belong is poised for greater growth. Hence my own personal time will be required to further the growth programmes of companies under my management.

Therefore, in order to achieve this, I would have to reduce my outside interests and therefore I hereby submit my resignation from the Board of Directors of Solara Active Pharma Sciences Limited.
